Tournament Date: **Saturday, June 3, 2023** USBC certification required. Entries close: 05/27/22

Walk-Ins permitted provided there is lane availability – add \$5.00 late entry fee.

Handicap: 90% of 210 in each class, over 210 bowls scratch.

NO CONFIRMATIONS WILL BE SENT VIA US MAIL. You will be notified only if your 1st request is not available.

Squad Times will be at **10:00 am** and **1:00 pm**. (*3rd squad may be added if warranted*)

TOURNAMENT RULES – PLEASE READ CAREFULLY

1. Present 2022-2023 USBC Certified Membership card. Report ½ hour prior to start time.
2. Bowlers shall use their 2021-2022 **composite** yearbook average. If no composite yearbook average or 2023 winter season average you must use the current winter/summer season composite average as of March 31, 2023 provided you have 21 games or more in one league. (Mail league standing sheet with your entry). All others excluded. Bowlers need not report a 15 or more pin increase in average. (*Rule 319 e-2 is waived*)
3. It is the bowler's responsibility to determine that the submitted average is correct. Rule 17 a-2 is in effect. Corrections must be made prior to completion of the first game.
4. Those wishing to bowl together must send entries and fees in the same envelope. Lanes will be assigned as entries are received. Three (3) games to be bowled on one set of lanes. **Each participant may enter more than once, but may only cash once.**
5. **NO MONIES WILL BE REFUNDED.** (*Rule 314*) In an emergency, a substitute may be allowed only before bowling starts, providing she is a current member of the Michigan Women's 500 Bowling Club and is a current USBC certified member.
6. Disputes or protests will be at the discretion of the tournament directors and shall be final unless an appeal is made in accordance with USBC rule 329.
7. Bowlers arriving late shall begin play and the score shall count with the frame then being bowled.
9. All prize fees will be returned 100% within each class on a ratio of at least one (1) prize for each 10 entries or a major fraction thereof. First place in each Class shall receive a trophy. In the case of a first place tie, co-champions will be declared.
